Sub: Position of Research Associate at the Centre

You are hereby offered the position of Research Associate at the Centre on the following terms and conditions:

- 1. Your appointment is on contract basis for a period of six months, w.e.f the date of joining, which will be extended or curtailed.
- 2. You will work in the Engineering Mechanics Unit, under the guidance of Prof. Diwakar S. Venkatesan, EMU.
- 3. You will be paid a remuneration of Rs.47,000/-p.m. plus admissible HRA.
- 4. The Centre will have no obligations to absorb you on completion of your assignment.
- 5. During the period of contract, you will not be permitted to accept any other employment of similar nature.
- 6. No terminal benefits are admissible under this contract when the services are discontinued.
- 7. You should get yourself examined for physical fitness before you join duty and produce a physical fitness certificate to this effect.

- 8. You are required to submit a report of work done to the President through your Unit Head once in six months or for the period if it is of shorter duration.
- 9. JNCASR should be acknowledged in all the publications arising out of the research carried out.
- 10. You will disclose to the Centre or to any person the Centre may direct you, the progress of the investigation made by you from time to time.
- 11. You will hold the results of all the investigations made by you while working in the Centre and all results obtained by you in any research connected with these investigations in trust for the Centre and disclose a full and complete description of the nature of your inventions and the mode of performing the same.
- 12. You are required to submit a Photostat copy of the following documents along with originals which will be returned after verification:
- (a) SSLC certificate/ Cumulative Record/School Transfer Certificate/ PAN card.
- (b) Certificates concerning your educational qualifications, previous experience etc.
- (c) Caste/Tribe certificate from a Competent Revenue Authority in the case of candidates belonging to SC/ST/OBC.
- 13. Your appointment is further subject to verification and acceptance of the certificates and other documents by the Centre.
- 14. You will be governed by the Rules, Regulations and Bye-laws of the Centre and orders in force, as amended from time to time.
- 15. You will not be entitled for any Traveling Allowances either for joining duty or at the time of completion assignment/termination.
- 16. No accommodation will be provided by the Centre.
